■ **Concept**

In recent years, European legislators have endeavoured to keep pace with technological progress and the associated risks and opportunities through comprehensive legislative initiatives in the field of IT and IP law. The development of modern media, in particular the ever-increasing relevance of artificial intelligence and data markets, is giving a considerable boost to European legal developments, but also brings with it a large number of unresolved issues.

The idea of the colloquium is to give young researchers in the field of intellectual property law as well as ICT law the opportunity to present the results of their scientific work and research to other young researchers as well as senior researchers in the field in order to discuss their topics and obtain valuable feedback for their further research work.

To this end, the presentations by young researchers will be supplemented by extensive comments from senior academics and practitioners with long and deep experience in the field of ICT and IP Law who will comment on the papers presented and give hints and insights from their perspective. This will provide valuable feedback for the speakers as well as enrich the discussion following the presentations. Practitioners and academics will get the chance to inform themselves about ongoing research projects and to meet young researchers from all over Europe.

This format has been implemented with great success in the past events. Speakers and participants had a truly academic and intense discussion on the topics presented.



■ **Objectives**

One of the objectives of the “Göttingen International Research Forum on Law and ICT/IP” is to support European-wide collaboration between young researchers as well as with academics and practitioners, thereby creating a platform where recent issues in the field of ICT/IP law can be presented and solutions be discussed. The topics can focus recent issues of the field as well as methodological problems the legal science faces when trying to deal with these issues.
