

# Information for Students of the Double Degree Programme in Development Economics in Cooperation with Universita degli Studi di Firenze (University of Florence), Italy Home University: University of Göttingen

#### I. Description of the double degree programme

The two-year English-language double degree master's programme in development economics is jointly offered by the University of Florence and the University of Göttingen. The programme is a partnership that offers students the opportunity to earn both a Master of Science (M.Sc.) in Development Economics offered by the Faculty of Business and Economics, University of Göttingen; and a Master of Science (M.Sc.) in Economics and Development offered by the School of Economics and Management of the University of Florence.

The programme is research-oriented, and combines the fields of applied development economics with a strong emphasis on quantitative methods with modules in international economics, international business and law. The programme is designed to prepare graduates to think analytically, and to equip them with cutting-edge research techniques, as well as in-depth knowledge of the driving forces behind economic development.

#### **Degree summary**

- The M.Sc. in Economics and Development comprises advanced study in macro- and microeconomic theory, applied
  economics, and policy analysis. Moreover, special emphasis is placed on research methodology and econometric
  analysis. Within the curriculum participants get also acquainted with relevant aspects of international law and
  governance.
- The M.Sc. in Development Economics is the only university-level master's programme in development economics in Germany. The University of Göttingen hosts Germany's largest internationally visible concentration of development economics researchers. The wide course offerings in the field of development economics (for which special attention is placed on quantitative methods) allow students to specialize in their specific area of interest.

Participants of the double degree programme complete two semesters at the University of Göttingen, and two semesters at the University of Florence.

Upon completion of the 120 ECTS (credit) programme, and having satisfied all the graduation requirements of both universities, participants will receive two separate and nationally recognised master's degree certificates: a Master of Science in Economic and Development, awarded by the University of Florence and a Master of Science in Development Economics, awarded by the University of Göttingen. Both certificates state that the degree is awarded within a joint programme and indicate that the respective certificates are valid only in conjunction with the other certificate. The double degree programme enables participating students to complete two degrees within four semesters (normally requiring four years).



#### II. Curriculum for students from the University of Göttingen

The double degree programme begins in the winter semester every year.

#### Semester 1 and 2

In the first semester (winter semester), participants commence their studies in Göttingen and continue their second semester in Göttingen where they complete mandatory and elective courses for the M.Sc. in Development Economics. At the end of their second semester, students travel to Florence and enrol there as well for their third and fourth semester. Students with home university Göttingen have to be enrolled at the University of Göttingen for the whole duration of the programme (four semesters). If the required courses (60 C) have not been completed by the end of the second semester, participants have the opportunity to return to Göttingen for a fifth semester, after completion of the required courses in Florence. Please note, in case you have to come back to Göttingen for a fifth semester, the defence of the master's thesis (which will be written in the fourth semester in Florence) will always be the last exam and for this occasion you have to return to Florence.

#### Semesters 3 and 4

From September to June, participants spend two semesters in Florence, and complete the course requirements for the M.Sc. Economics and Development, participate in a Joint Seminar and write their master's thesis under the regulations of the University of Florence. The master's thesis comprises 21 ECTS and will be written under the supervision of professors from the University of Florence. The examination requirements for the thesis will be applied from the University of Florence including a thesis defence at the very end of the double degree programme. The thesis will apply towards both degrees as part of the double degree programme. The courses and the master's thesis will be fully recognized as the study abroad component for the MSc in Development Economics.

#### **Program structure**

#### **Enrolment**

Students will be enrolled at both the University of Göttingen and the University of Florence for the entire duration of the four semester-long programme. #### Semester fees

During the semesters at the University of Göttingen, students must pay the regular semester fees of the University of Göttingen; while during the time at the University of Florence, students will be exempt from paying regular fees in Göttingen. Instead, a special reduced fee is applied, amounting to approx. 75€ per semester. Additionally, students are not required to pay regular tuition to Florence, students are required to pay only administrative fees.
