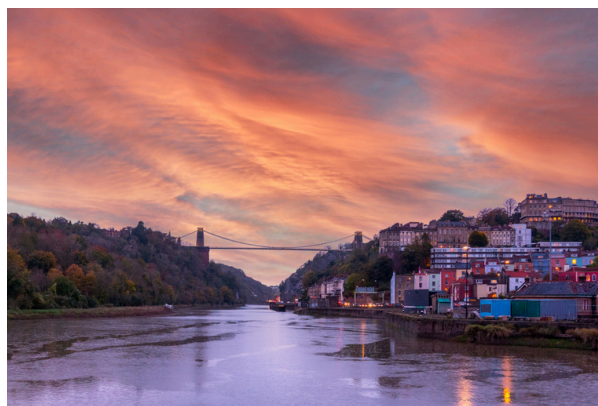


# UNIVERSITY OF BRISTOL STUDY ABROAD (SUBJECT PATHWAY) 2025/26 FACT SHEET

<p><b>Study Abroad (Subject Pathway) Programme</b></p>	<p>This programme is designed for our exchange partnerships, where the agreement between our two institutions covers one or more designated subject area(s). Your students will be nominated under the <a href="#">Study Abroad (Subject pathway) programme</a> and assigned to the academic area in which we have agreed to exchange students. If we have multiple Subject Pathway agreements, students must be nominated to one specific academic area. They will take the majority of their units within this subject, with the option to take a small number of credits (a maximum of 20 credits per semester) in other academic areas of interest.</p> <p><b>Nomination deadlines:</b>  Autumn Semester/full year – 30 May 2025  Spring Semester – 10 October 2025</p> <p><b>Application deadlines:</b>  Autumn Semester/full year – 8 June 2025  Spring Semester – 19 October 2025</p>
<p><b>Academic Requirements</b></p>	<p><b>3.0 GPA (based on US 4.0 system) or equivalent</b></p> <p>Students must have completed at least one year of study at university level at the time of their application which should be evidenced on their transcript. For 4-year degrees, we recommend at least 2 years of study. We have a grade conversion in place for all partners who don't grade on the 4.0 GPA system. <p><b>English Language Requirements</b></p>	<p>All inbound students, including year-long and single-semester students, are required to provide evidence that they meet our English Language requirements as part of their application. A full list of accepted English language certificates for the 2025/26 academic year can be found on our <a href="#">Study Abroad Language Profile</a>. Please note the length of validity of each accepted certificate as noted on the profile.</p> <p>Students who do not meet the English language requirements may be eligible for our STABEL (Study Abroad with English Language) programme. Please see further information about this below.</p> <p>If your institution fully teaches and assesses in English, and can evidence that your English language entry requirements are equivalent to those required to come to Bristol, we may be able to put a Medium of Instruction letter in place for your students which would exempt them from the English language requirements. Please contact us on <a href="mailto:cfsa-inbound@bristol.ac.uk">cfsa-inbound@bristol.ac.uk</a> for further information about this prior to nominating the students.</p> <p><b>Translation of Language Qualifications for students who need a Student Visa:</b></p> <p>For students who require a Student visa to study at Bristol, we can only accept proof of English language qualifications in English. If a qualification isn't in English, the student must provide a professional or certified translation, including the contact details for the translator or translation company. This is to comply with UK government guidelines for the Student visa.</p>

<p><b>STABEL (Study Abroad with English Language) Programme</b></p>	<p>For students who don't currently meet the English language requirement for the Study Abroad (Subject pathway) programme, <u>STABEL</u> combines Study Abroad with a pre-sessional English language course starting in June or July. This intensive English language course will prepare them for study in Bristol and lasts for six or ten weeks, depending on their current English language level. If they successfully complete the pre-sessional course, they will progress onto the Study Abroad (Subject pathway) programme in September.</p> <p>Students can choose an online or on-campus option for the pre-sessional programme. The teaching is the same for both options but the on-campus option gives students the chance to familiarise themselves with life on campus and get an introduction to living in the UK before regular teaching begins in September. You can find out more information about the pre-sessional courses <u>on the website</u>.</p> <p><b>Deadlines:</b>  Nomination deadline: 17 March 2025  Application deadline for 10-week pre-sessional programme: 23 March 2025  Application deadline for 6-week pre-sessional programme: 30 March 2025</p> <p>The English Language requirements for STABEL vary depending on the length of the pre-sessional course. We can <b>only</b> accept IELTS Academic for UKVI from authorised test centres for entry to the STABEL programme as follows:</p> <ul style="list-style-type: none"> <li>• STABEL with 6-week pre-sessional course: IELTS Academic for UKVI 6.0 overall with 5.5 in all skills</li> <li>• STABEL with 10-week pre-sessional course: IELTS Academic for UKVI 5.5 overall with 5.0 in all skills</li> </ul> <p>Please note that the STABEL programme has <u>additional tuition fees</u> for the pre-sessional course.</p>
<p><b>Nomination Instructions - All Programmes</b></p>	<p>Please send a list of nominated students to <a href="mailto:cfsa-inbound@bristol.ac.uk">cfsa-inbound@bristol.ac.uk</a> including student's full name, student email address, duration of study and the subject area into which they are being nominated (as per the terms of our agreement). We will follow up with information to the student(s) about how to apply and copy in the email address from which they were nominated for reference.</p> <p>When nominating a student, please make sure they are suitable for the programme, based on our entry requirements, and that they have all the required documents ready to be submitted before our application deadline. This will ensure a smooth application process for both you and your students.</p>



<b>Application Instructions- All Programmes</b>	<p>Students apply by completing the online application form which can be signed digitally by the student. As part of their application, students will be asked to submit supporting documents. Further details about the application and required documents can be found on the <a href="#">Study Abroad (Subject Pathway) programme</a> page. Please advise students that they will need to have these documents ready in order to apply. The application pages of our website are updated in January each year after we have welcomed our Spring semester students.</p> <p>Where a transcript provided as part of an application is not in English, we require an official/certified translation. Please note the translation can be made by a professional translator and include the translator's credentials along with their official declaration that the translation is accurate or we can accept transcripts translated and certified by a partner university. Where universities translate and certify documents, these need to be stamped, dated, and signed by the university.</p> <p><b>Please note that we cannot guarantee to accept applications from students after the deadline, including applications which have been partially submitted or are missing some supporting documents.</b></p>
<b>Visa Information</b>	<p><b>Please ensure that students have a valid passport at the point of application or are due to receive one very soon if they have applied for a new/renewed passport.</b></p> <p>Non-UK/Irish passport holders coming for more than 6 months must apply for a <a href="#">Student visa</a>.</p> <p>Non-UK/Irish passport holders who will be studying at Bristol for only one semester will be subject to immigration control and must meet the requirements of the Standard Visitor visa. Some nationalities will need to obtain a Standard Visitor visa in advance of travelling (visa nationals) whilst others will be able to obtain permission to enter the UK as a Standard Visitor on arrival at the border without having to apply for the visa in advance (non-visa nationals). To check whether they need to apply in advance, students can use <a href="#">this online tool</a> and they should also read the information on the University website about the <a href="#">Standard Visitor visa</a>.</p> <p>Students from certain non-visa nationalities travelling to the UK from January 2025 will be required to apply for the Electronic Travel Authorisation (ETA). The ETA gives individuals permission to travel to the UK and must be obtained prior to travelling. Please note that the ETA gives permission to travel to the UK only, individuals must still obtain permission to enter the UK as a Standard Visitor on arrival at the border. For a complete list of the nationalities, please refer to the <a href="#">UK Government website</a>. Please note that your students will not require an ETA if they have applied for and secured either a Student visa or Standard Visitor visa prior to travelling.</p> <p>More information is available on <a href="#">our website</a> and further guidance is sent to students after they have accepted their offer. <p><b>Unit Levels and Credits</b></p>	<p>Undergraduate degrees in the UK are three-year programmes. Inbound Study Abroad students can choose units from all three years. For subjects that students haven't studied at their home institution, we recommend first-year units. Second-year units are most common for students taking their major/minor abroad, and third-year units are suitable for students in their major subject if they are close to graduation. Second-year and third-year units may be subject to pre-requisite checks with the relevant academic department at the start of the semester. Please also note that, for first-year units in STEM subjects, an equivalent of A-level background knowledge is assumed.</p> <p>A full credit load at Bristol is 60 credits (30 ECTS) per semester or 120 credits (60 ECTS) for a full academic year. Students cannot exceed this credit load and must take a minimum of 50 Bristol credits per semester (100 per year) to be considered a full-time student and to meet the conditions of their visa. Student must engage with classes and assessments for all units regardless of which units they plan to transfer for credit at their home university.</p>
<p><b>Unit General Guidance</b></p>	<p><u>Study Guides</u> with a list of all available units for 2025/26 will be published on the Centre for Study Abroad Inbound website in April 2025. Whilst we make every effort to place students on as many of their top unit choices as possible, please note that unit choices cannot be guaranteed, and we do not advise students to rely on specific units where it may impact their academic progression or graduation.</p>
<p><b>Further Unit Information</b></p>	<p>The Schools of Medicine, Dentistry and Veterinary Science are not open to Study Abroad students.</p> <p>The restrictions below are accurate as of January 2025 but further updates and changes will be highlighted on our website. For all of the subject areas listed below, we strongly advise that students review our <u>Study guides</u> before submitting their application.</p> <p><b>Engineering:</b> There are a limited number of single-semester units available in some areas of Engineering. Single-semester Engineering students may therefore need to be flexible in the units that they take.</p> <p><b>Computer Science:</b> Please note that Computer Science units are only available at third- and fourth-year level and therefore are only suitable for students who have already completed 2 or 3 years of a Computer Science degree. There are some restrictions in the combination of units that can be taken, particularly for TB1 units.</p> <p><b>Psychological Science:</b> Psychology is taught as an experimental science rather than a social science at Bristol. Students taking Psychology units are generally required to have a strong background in Chemistry, Biology and Neuroscience. Please note that the School of Psychological Science recommends that students only undertake one 3rd year unit per semester. If students are able to come to Bristol for the full academic year this would give them a wider range of unit choices as the school does not offer a large number of 2nd or 3rd year units in each semester.</p>



<b>Student Experience</b>	<p>We want to ensure that Study Abroad students have an unforgettable experience. That's why we have a dedicated Student Experience team who run a diverse range of events and activities for Study Abroad students to support their academic, personal and professional growth. The Student Experience team runs events throughout welcome week and the semester. Events include regular casual meet-ups, academic workshops, day trips and weekend trips. Many of these events are free to attend, while others are subsidised.</p> <p>Students can browse the current <a href="#">Student Experience programme</a> or check out our <a href="#">Instagram</a> to get a taste of the activities on offer.</p>
<b>Accommodation</b>	<p>University of Bristol has a range of accommodation options. On our website, students can find out more about <a href="#">accommodation for Study Abroad students</a>, including the types of rooms available and accommodation costs.</p> <p><b>Accommodation guarantee:</b> <b>September entry:</b> Exchange students from institutions outside of Europe and all non-exchange students are guaranteed an offer of a place in University accommodation, if they apply by the deadline. Exchange students from institutions within Europe are not guaranteed an offer but are still welcome to apply and are given support to find private accommodation. <b>January entry:</b> Non-exchange students are guaranteed an offer of a place in University accommodation, if they apply by the deadline. We cannot offer an accommodation guarantee to exchange students, but we make every effort to place as many students as possible in a University residence or help them find private accommodation.</p>
<b>Disability</b>	<p>We want students to make the most of their time at Bristol, and there is a range of services to support all aspects of their university life. Disability Services offer <a href="#">disability support</a> and advice for students with a range of disabilities, learning difficulties and other health and mental health conditions. Students are encouraged to declare their disability when they fill out their application or contact the Centre for Study Abroad team early in the application process so we can advise them on what support is available to them and how to access it. There will also be opportunities throughout their studies to declare a disability, though we strongly recommend that they inform us at the application stage. This allows us to support students from the start of their studies at Bristol and offer support based on their specific needs.</p>
<b>Health and Insurance</b>	<p>Students studying with us for less than six months on a Standard Visitor visa will not be covered by the National Health Service (NHS) and should therefore make sure that they obtain adequate medical insurance that covers them while they are abroad. Students studying with us for a full academic year travelling on a Student visa, and those with a valid UK/Irish passport, will be covered by the National Health Service and therefore do not require medical insurance, but will still need to take out travel insurance for flights etc. and contents insurance for their belongings. Student visa holders pay the NHS surcharge as part of their visa application. Please note that the University is not able to make recommendations about insurance providers.</p> <p>Find more information about healthcare for international students on <a href="#">this page</a>.</p> <p>Students who are EU or Swiss nationals may be eligible for an IHS refund if they have an EHIC card covering their stay.
