Only those regulations published by the Georg-August-Universität Göttingen in its Official Bulletins are legally binding. Any claims to rights or titles resulting from the English translation of these regulations are expressly excluded.

The Senate decided on 16.05.2007 and the Presidential Board decided on 06.06.2007 on the regulations about the charging of fees for the Master's degree programme "Sustainable Forest and Nature Management - SUFONAMA" (§ 13 section 3 and 7 NHG (Lower Saxony Higher Education Act) in the version of the announcement of 24.06.2002 (Nds. GVBI. (Lower Saxony Law and Official Gazette) p. 286), last amended by Article 2 of the Act of 21.06.2006 (Nds. GVBI. (Lower Saxony Law and Official Gazette) p. 239). In the following the regulations are announced:

# § 1 Charging, scope, use

- (1) The Georg-August-Universität Göttingen charges fees in the sense of § 13 section 3 NHG to students who are enrolled or re-registered for the Master's degree programme "Sustainable Forest and Nature Management".
- (2) The Georg-August-Universität Göttingen shall not be liable for additional costs incurred by the participants in connection with the procurement of working materials, excursions, etc. as a result of the advanced study programme. These additional costs are not covered by the fees.
- (3) The levying of further fees and charges on the basis of other legal provisions shall remain unaffected.

### § 2 Amount of fees, due date, calculation principles

(1) <sup>1</sup>The fee according to these regulations is 600 euros per study semester. <sup>2</sup>Excepted from this are

students who are on leave of absence for an entire semester or who are completing a period of study abroad as provided for in the examination or study regulations, as well as students in the SOKRA-TES/ERASMUS programme.

- (2) In deviation from section 1, foreign or stateless students who are not considered equal to Germans according to § 7 of the Lower Saxony Ordinance on the Allocation of Study Places by Institutions of Higher Education (Hochschul-VergabeVO) of June 22, 2005 (Nds. GVBI. p. 213), as amended, shall be charged fees in the amount of 2,500 euros per semester of study.
- (3) <sup>1</sup>Fees are due for the first time upon enrollment and then each time upon expiration of the re-registration period. <sup>2</sup>If the application for enrollment is rejected, any fees paid shall be refunded. <sup>3</sup>The deadlines for re-registration are specified in the enrollment regulations. <sup>4</sup>Enrollment or re-registration without payment of the due fees is excluded.
- (4) Fees shall be collected by the general university administration.

# § 3 Fee debtor

The person liable to pay the fee shall be the person who incurs the charge within the meaning of § 1 section 1.

## § 4 Final provisions

- (1) The fees shall be charged for the first time as of the winter semester 2007/2008.
- (2) This regulations about the charging of fees shall enter into force on the day following its publication in the Official Announcements of the Georg-August-Universität Göttingen.
