Only those regulations published by the Georg-August-Universität Göttingen in its Official Bulletins are legally binding. Any claims to rights or titles resulting from the English translation of these regulations are expressly excluded.

#### **Faculty of Humanities:**

Following the resolution of the Faculty Council of the Faculty of Humanities on 29.06.2022, the Presidential Board of the Georg-August-Universität Göttingen has approved the fourth amendment to the Examination and study regulations for the Bachelor's degree programme "Weltliteratur/World Literature" on 10.02.2022 in the version published on 10.10.2018 (Official Announcements No 55/2018, p. 1384), last amended by decision of the Presidential Board on 28.06.2021 (Official Announcements I no. 41/2021 p. 969 (§ 44 section 1 sentence 2 NHG in the version published on 26.02.2007 (Nds. GVBI. p. 69), last amended by Article 7 of the Act dated 23.03.2022 (Nds. GVBI. p. 218); § 41 section 2 sentence 2 NHG; §§ 37 section 1 sentence 3 no. 5 b), 44 section 1 sentence 3 NHG).

# Examination and Study Regulations for the Bachelor's degree programme "Weltliteratur/World Literature" of the University of Göttingen

#### § 1 Scope

- (1) The "General Examination Regulations for Bachelor's and Master's Degree Programmes as well as other courses and degrees offered at the Georg-August-Universität Göttingen" (APO) apply in their respectively valid forms to the Bachelor's degree programme "Weltliteratur/World Literature" at the University of Göttingen.
- (2) These regulations stipulate the additional provisions for the Bachelor's degree programme "Weltliteratur/World Literature".

#### § 2 Objectives of the Programme; Purpose of the Examination; Working Fields

(1) <sup>1</sup>The Bachelor's degree programme "Weltliteratur/World Literature" teaches students scientific principles and methods in the subject of World Literature, along with other professional field-related competencies. <sup>2</sup>This enables the graduates of this course of study to apply and communicate scientific findings in the chosen subjects in practice, to form professionally sound judgements, to critically reflect on new scientific results and to assess their practical value. <sup>3</sup>They are enabled to follow the scientific development of their chosen subjects through self-study.

(2) <sup>1</sup>The Bachelor's degree programme "Weltliteratur/World Literature" is divided into the fields of literature and cultural studies, language practice and preparation for professional activities.

#### (3) <sup>1</sup>Students are able

- to explore the field of tension between national and world literary perspectives and thereby understand the ambivalence between interculturality and cultural identity;
- to understand the specifics of the fundamentally different world literary relationship styles and thereby also the resulting cultural consequences;
- to reconstruct and culturally contextualize literary relationships on the basis of a knowledge of basic literary style formations;
- to recognise the possibilities of expression and the basic genres resulting from them, or the genre specificity for inter-cultural literary comparison, and to analyse their combinatorics, their interaction and their mutual influence;
- to examine world literary relational phenomena with their knowledge and ability to deal with reference texts received worldwide in the sense of the current expansion and renewal of the concept of world literature;
- to understand the different concepts of world literature and to understand the controlled and structural processes of literary canonization that essentially control the globalisation of literature.

#### <sup>2</sup>In addition, the students obtain

- a knowledge of the literary aspects of migration and identity, as well as post-colonial and transcultural approaches in literary studies.
- (4) <sup>1</sup>In addition to a standard-compliant and reliable command of spoken and written German and English, the Bachelor's subject "Weltliteratur/World Literature" also requires knowledge or learning of another literary language to a level that allows reading of source texts. <sup>2</sup>This makes it possible to at least partially do justice to the essentially linguistic character of literature.
- (5) <sup>1</sup>Students are trained for the international book and literature market. They acquire
  - elementary literary knowledge of the world;
  - the skills to understand literature as a global and globally networked phenomenon and to classify literary texts in this network;
  - techniques of scientific and journalistic work on literary texts;
  - the repertoire of literary processes and their changing functions;
  - the competence to judge literary quality by their respective handling of this repertoire and its creative functionalisation:
  - the ability to classify literary texts in their immediate cultural context and to assess their potential beyond this context.

<sup>2</sup>These skills qualify them as actors in the literary field - from author to literary agent, publisher, editor, rights dealer, translator to literary mediator, manager of literary houses, literary festivals, literary fairs, literary museums and exhibitions.

- (6) The bachelor examination will ascertain whether the examinee has indeed acquired the specialised knowledge required for the purpose of the degree programme, understands the connections and possesses the ability to work in accordance with scientific principles and to communicate scientific insight.
- (7) Depending on the use of options at course level, the programme prepares for a possible transition to consecutive Master's degree programmes in the following subject areas: Slavic Philology, Medieval and Renaissance Studies, Romance Philology, Arabic Studies/Islamic Studies, Intercultural German Studies, North American Studies, English Philology, German Philology and Scandinavian Studies.

#### § 3 Recommended Prior Knowledge

<sup>1</sup>We recommend a knowledge of the basic texts of one's own cultural area - for European applicants for university, e.g., the Bible, Homeric epics or well-known medieval sagas - as well as fairy tales. <sup>2</sup>Reading cultural or literary historical overviews is also useful for preparation. <sup>3</sup>A list of recommendations will be made available on the programme's websites.

#### § 4 Academic Degree

Once the bachelor degree examination has been passed, the Georg-August-Universität Göttingen awards the academic title "Bachelor of Arts" (abbreviated: "B.A.").

#### § 5 Structure of the Course; Standard Length of Course

- (1) The Bachelor's degree programme starts with the winter semester.
- (2) The standard course length is six semesters.
- (3) The degree programme cannot be done part-time.
- (4) The academic programme comprises 180 credits (ECTS credits; abbreviated as: C), which are distributed as follows:
  - a) to the core subject studies at least 132 C,
  - b) to the area of professionalisation at least 31 C,
  - c) 12 C for the Bachelor thesis.
- (5) <sup>1</sup>The study and examination components are to be accomplished in compulsory and elective compulsory modules; the module directory (appendix I) stipulates these binding. <sup>2</sup>The module index is published separately; it is part of this regulation as far as the modules are listed in the module

directory (appendix I). <sup>3</sup>A summary of the distribution of modules across the periods of study is contained in the appendix (appendix II).

(6) Appendix III gives recommendations for the enrolment of courses within the modules of the curriculum with a view to the connectivity of consecutive Master's degree programmes at the University of Göttingen.

#### § 6 Admission to Courses with a Restricted Number of Participants

- (1) <sup>1</sup>The admission to certain courses or modules (in the following: Courses) can be restricted by a resolution passed by the Faculty Council responsible, if the inherent nature of the content of said courses or their proper implementation necessitates such a measure. <sup>2</sup>The conditions of admission must be announced in advance. <sup>3</sup>The person in charge of the course will allocate the places. <sup>4</sup>In the event of any conflict, the dean of studies concerned will make a ruling.
- (2) ¹In terms of the admission to courses as described under section 1 that offer a restricted number of places, the following procedure shall be applied in the event that the number of registrations exceeds the number of places and in the event that it is not possible to offer any parallel event: Registrations will be considered in order of ranking groups in the following order, whereby the registration by students in this degree programme, or in a degree programme for which the involved faculties provides teaching exports, will be given preferential treatment in the allocation of courses that refer to compulsory or elective compulsory modules of this degree programme or the imported degree programme over students of other degree programmes external to the faculty:
  - a) Registration by students in the respective subject semester, for which the seminar is offered as a compulsory course according to the Study or Examination Regulations, and those who have not attended this seminar and successfully completed it. Equal ranking shall be given to registration by students who satisfied the preconditions as laid down in sentence 1 in the previous semester and, despite orderly registration, were unable to receive a place or, due to allocation of a compulsory course taking place simultaneously in a subject studied concurrently, were unable to accept the allocation. Sentences 1 and 2 apply accordingly to courses relating to sections within a degree programme.
  - b) Registration by students in subject semesters, who deviate from the preconditions laid down in letter a) by one semester or were unable to successfully complete the course in the previous semester or were unable to regularly attend or successfully complete the course in the previous semester due to illness without having a leave of absence. A doctor's certificate must be submitted as proof of illness.
  - c) Registration by students from subject semesters who deviate by two or more semesters from the preconditions laid down in letter a).

- d) Registration by students in the respective study semester or section of their degree programme for whom the course is provided as an elective compulsory course according to the Study Regulations, and who satisfy the requirements defined in letter a).
- e) Registration by students from subject semesters who deviate by one or more semesters from the requirements defined in letter d).
- f) Registration by students who wish to attend the course as an elective course within their degree programme.
- g) Other registration by students.

<sup>2</sup>In the event that it is not possible to consider all registrations by students within one ranking group, the time of registration shall be decisive. In the event that this still produces equality of rank, a lottery procedure shall decide. <sup>3</sup>The procedure shall be announced with sufficient notice in advance. <sup>4</sup>At the same time as its resolution as specified under sentence 1, the Faculty Council responsible must define a final closing date for registrations to the course in question.

- (3) <sup>1</sup>In the event that all students within ranking groups specified under section 2 letters a) to c) in a semester cannot be considered for a course, the Faculty Council responsible shall specify a sufficiently higher number of places for the next semester within the scope of what is possible in terms of staff and infrastructure. <sup>2</sup>This shall not apply in the event that the expected number of participants will most probably permit consideration of the students assigned to ranking groups as specified in section 2 a) to c).
- (4) The responsible Faculty Council is entitled to install a central procedure for access to certain courses under its auspices that deviates from the procedure laid down in sections 2 and 3.

#### § 7 Subject-specific Examination and Teaching Types

- (1) Besides the examination components allowed according to the provisions of APO, the following subject-specific examination components can be planned: portfolio, self-study, mid-term written examination, mid-term oral examination, language competence exam und mid-term assignment/paper.
- (2) A portfolio ('document folder') helps students document and annotate their own periods of studies in a reflective manner. Portfolios collate various shorter tasks (e.g., logs of hours, internship report, reading summaries; multimedia tasks may also be included).
- (3) A self-study unit serves to work on core areas of the selected lecture in depth. These can be primary texts, central texts of secondary literature or other materials (e.g., works of art, extra-literary texts).
- (4) <sup>1</sup>A mid-term written examination tests the knowledge acquired in a lecture or in an exercise at approximately halfway through the course. <sup>2</sup>It lasts 45 minutes.

- (5) A mid-term oral examination tests the speaking and listening skills acquired in a language course approximately halfway through the course. It lasts approximately 20 minutes.
- (6) <sup>1</sup>A language proficiency exam covers all five language skills (listening, reading, writing, oral expression, translation). <sup>2</sup>It consists of an oral part (speaking and listening comprehension; approx. 10-30 min.) and a written part (text editing, grammar, vocabulary, translation; total length of the exam approx. 150 min.).
- (7) A mid-term paper or mid-term assignment is a written assignment of no more than 3000 words, which documents the learning progress about halfway through a lecture.

#### § 8 Admission to the Bachelor Thesis

- (1) <sup>1</sup>The Bachelor thesis can be written in all included fields of study or in another selected field of study (the specific regulations for the fields of study for the Bachelor thesis can be found in appendix III.). <sup>2</sup>Admission to the Bachelor thesis in the subject "Weltliteratur/World Literature" requires proof of at least 100 C from the curriculum. <sup>3</sup>As a rule, the Bachelor thesis is supervised by university teachers from two different participating institutions.
- (2) <sup>1</sup>Admission to the Bachelor thesis must be applied for to the responsible examination board. <sup>2</sup>The following material must be enclosed with the application:
  - a) evidence that the requirements specified in Section 1 have been met,
  - b) the proposal of topic for the Bachelor thesis,
  - c) a proposal for the first academic advisor or the second academic advisor,
  - d) a confirmation of the first academic advisor and the second academic advisor,
  - e) a declaration specifying that the bachelor degree examination has not been failed definitively or registered as definitively failed in the same or comparable bachelor degree programme at a domestic or foreign university.

<sup>3</sup>The proposals under Lit. b) and c) as well as the proof as specified under Lit. d) are unnecessary if the student provides assurance that he or she has been unable to find an academic advisor. <sup>4</sup>In this case, the examination board shall appoint supervisors and shall determine the topic of the Bachelor thesis.

(3) <sup>1</sup>The examination board shall decide on admission. <sup>2</sup>This is to be rejected if the qualifications for entry are not fulfilled or the bachelor examination in the same or similar degree programme at a domestic or foreign university has been definitively failed.

#### § 9 Bachelor Thesis

(1) <sup>1</sup>The provisional working topic of the Bachelor thesis should be agreed with the proposed academic advisor and submitted with confirmation from the second academic advisor to the

examination board concerned. <sup>2</sup>In the event of the candidate being unable to find an academic advisor, the examination board will specify an academic advisor and a topic. <sup>3</sup>The candidate's view should be considered in choosing the topic. <sup>4</sup>The right to make a proposal for the choice of topic does not constitute a legal right. <sup>5</sup>The chairman of the examination board will issue the topic of the Bachelor thesis. <sup>6</sup>The time of issue must be recorded.

- (2) <sup>1</sup>The preparation time of the Bachelor thesis amounts to 12 weeks. <sup>2</sup>Upon application by the candidate, the examination board can extend the deadline for submitting the thesis by a maximum of 4 weeks, upon agreement with the first academic advisor and existence of an important reason that cannot be attributed to the candidate. <sup>3</sup>An important reason normally exists in the case of an illness that is to be notified immediately and established by producing a medical certificate.
- (3) <sup>1</sup>The topic can be returned only once and only within the first 4 weeks of the time allotted for completing the thesis. <sup>2</sup>A new topic must be agreed upon immediately, but no later than within 4 weeks. <sup>3</sup>In the event that a Bachelor thesis is repeated, the topic may be returned only in accordance with sentence one if the examinee has not resorted to this option in the first submission of the Bachelor thesis.
- (4) <sup>1</sup>The Bachelor thesis must be submitted within the due period to the relevant examination office in the format of a commonly used word processing program or in PDF format (unprotected). <sup>2</sup>The time of submission should be recorded. <sup>3</sup>Upon submission, the candidate should declare in writing that he or she has independently compiled the work and has not used any sources and tools other than those specified.
- (5) <sup>1</sup>The examination board will assign the Bachelor thesis to the first supervisor as well as to the second supervisor as reviewers/evaluators. <sup>2</sup>Each reviewer will award a grade.
- (6) The duration of the assessment procedure shall not exceed 8 weeks.

#### § 10 Reassessment Guidelines for Grade Improvement

<sup>1</sup>A module examination for the modules B.WLI.101 "Function and Eras of World Literature" passed at the first attempt within the standard study period can be repeated once for the purpose of improving grades. <sup>2</sup>Reassessment does not lead to any devaluation of the grade. <sup>3</sup>The repetition must take place at the next possible examination period.

#### § 11 Examination Board

(1) <sup>1</sup>The examination board consists of five members appointed by the respective group representatives on the Faculty Council for the Faculty of Humanities, specifically, three members of the professorial group, one member of the staff group and one member of the student group. <sup>2</sup>At the

same time, a deputy is nominated for each member. <sup>3</sup>If a member or a representative steps down prematurely, a substitute will be nominated for the remaining tenure.

- (2) <sup>1</sup>The implementation and organisation of the examination procedure is delegated to the examination management at the Faculty of Mathematics and Computer Science, without prejudice to the competencies of the dean of studies. <sup>2</sup>It also maintains the examination records. <sup>3</sup>It reports regularly to the faculty on examinations and course lengths. <sup>4</sup>In this case, compliance with the standard course lengths and the distribution of module and current average grades in particular should be itemised. <sup>5</sup>The report is to be published by the university in a suitable manner.
- (3) The examination board will choose a chairperson and their deputy from the professorial group.
- (4) The ongoing operations may be transferred to the chairperson.

#### § 12 Grade Point Average; Peremptory Failure

- (1) The bachelor examination is passed if at least 180 credits were acquired and all of the required module examinations as well as the Bachelor thesis have been passed.
- (2) The overall grade "summa cum laude" (with distinction) is awarded if the grade point average of all examination performances
  - a) is at least 1.3 and the Bachelor thesis is awarded the grade 1.0, or
  - b) reaches at least the grade 1.5, the Bachelor thesis is awarded the grade 1.0 and the examination board decides on the award on the basis of a special achievement; special achievements include, in particular,
    - aa) a grade average that is considerably above the grade average of the technically comparable graduates of the same semester is regarded as special achievements,
    - bb) a study or examination achievement of considerable scientific significance, which may result in particular from a publication in a specialist journal or from an award.

#### § 13 Study Consultation and Support

(1) <sup>1</sup>Students are required to visit the faculty's examination and study advisory service as well as the specialist advisory service of the included subjects throughout their studies and to consult, in the case of a corresponding study option, the coordination of the double-degree programmes of the participating subjects. <sup>2</sup>These are responsible for supporting individual study planning. <sup>3</sup>Students are recommended to seek academic advising especially at the beginning of their studies and before making decisions about changes in their study plans; furthermore, it should be consulted when planning to study abroad, when wishing to exercise the double degree option according to § 14, § 14a and § 14b and after failing examinations.

- (2) All lecturers of the study area and their colleagues are available during their consulting hours for providing study advisory service relating to special study areas.
- (3) Individual study advisory service is provided by a lecturer of the relevant subjects, if the student is entitled to only one reassessment opportunity for the examination of a compulsory module or elective compulsory module.
- (4) In examination matters and for questions regarding accreditation of study and examination prerequisites, advice is offered especially by the colleagues of the responsible examination office.
- (5) <sup>1</sup>Besides the study advisory service of the faculty, the students have access to the Central Student Advisory Office of the Georg-August-Universität. <sup>2</sup>As general study advisory service, it furnishes information in the case of interdisciplinary issues, as well as study opportunities, contents, structure and requirements of a course of studies and advises in the case of study-related personal difficulties.

#### § 14 Double Degree Programme with the University of Arizona (UA)

- (1) <sup>1</sup>The University of Göttingen and the University of Arizona, Tucson, Arizona, United States of America (henceforth: UA) jointly conduct a double degree programme which may be completed within this course of study. <sup>2</sup>The regulations of these examination and study regulations apply unless specified otherwise below. <sup>3</sup>Teaching offers from the UA are exclusively regulated by the UA.
- (2) <sup>1</sup>Students of the Bachelor's degree programme "Weltliteratur/World Literature" are eligible to participate in this programme according to the following regulations. <sup>2</sup>The double degree programme may only be entered during a winter semester. <sup>3</sup>A further prerequisite is that the UA allows admission to students by means of its own regulations.
- (3) <sup>1</sup>Students are permitted for entry if they have completed modules of the Bachelor's degree programme worth overall at least 50 C, as well as if they possess language skills in English at the minimum level of B2+ according to the CEFR (German: GeR). <sup>2</sup>If language skills in English have not yet been demonstrated at level C1 of the Common European Framework of Reference for Languages (CEFR), modules to the required extent must be successfully completed before the start of the mobility in the third year of study, on the basis of which this language level is achieved according to the criteria of the UA; otherwise, participation in the double degree programme is excluded.
- (4) <sup>1</sup>The application for acceptance into the double degree programme must be filed by 10<sup>th</sup> October at the Slavic Department; the earliest possible date for submission is the end of the second subject semester. <sup>2</sup>The application must comprise the following documents:
  - a certification for the examination achievements completed so far including the number of credits

- a certification of the required language skills in English as specified under section 3
- a personal data sheet (curriculum vitae listed in table format) in either German or English comprising a meaningful presentation of the student's past education, which emphasises on his or her job-related practical knowledge, subject-matter-oriented qualifications or studyrelated experiences from abroad.
- (5) For students after section 2, five study places per year are available; in the event that more students eligible for entry apply than study places are available, a selection procedure is carried out according to the following regulations:
- a) <sup>1</sup>The Faculty of Humanities of the University of Göttingen forms a selection committee for the preparation of the selection decision. <sup>2</sup>The selection committee has three members who are full-time scientific staff or faculty members, as well as one student member in advisory function. <sup>3</sup>At least one member must be a professor. <sup>4</sup>The members are appointed by the Faculty Council of the Faculty of Humanities. <sup>5</sup>The members' term in office lasts two years, the student member's lasts one year. <sup>6</sup>Repeated appointments are possible. <sup>7</sup>The selection committee has a quorum if at least two voting members are present. <sup>8</sup>The selection committee's obligations are the following:
  - aa) surveying the submitted applications for formal correctness,
  - bb) conducting the selection interviews according to section 6,
  - cc) making decisions on the admission or rejection of applying students.
- b) <sup>1</sup>The selection is carried through on the basis of a ranking list beginning with the student who has reached the highest score (max. 26 points), which is attributed based on the following criteria:
  - aa) based on the current average grade of the achievements completed at the time of application:

1,0 up to and including 1,2	18 points,
more than 1,2 up to and including 1,5	15 points,
more than 1,5 up to and including 1,8	12 points,
more than 1,8 up to and including 2,1	9 points,
more than 2,1 up to and including 2,4	6 points,
more than 2,4 up to and including 2,7	3 points,
more than 2,7 up to and including 3,0	1 point,
more than 3,1 up to and including 4,0	0 points.

bb) based on the selection interview with a duration of ca. 15 min. serving the assessment of the student's degree of qualification.

<sup>2</sup>In the event of equal ranking, the average grade of the achievements achieved at the time of application is decisive. <sup>3</sup>The selection interview normally takes place face-to-face with the selection committee at the university in October; the students are formally invited to attend the selection interview by the university in a timely manner; in special cases, video conferencing or interviews on the phone are acceptable, so long as the identity of the student can be established unequivocally; in such cases, the details of the procedure are laid down by the selection committee. <sup>4</sup>The essential questions and answers of the interview must be put on record, which at the end must be signed the members of the selection committee; the record must document time and place of the interview, the names of the committee members, the name of the student, and the assessment. <sup>5</sup>The selection interview includes the following parameters of qualification:

- aa) language skills and cultural competence; interaction with the selection committee,
- bb) intercultural competence,
- cc) awareness of the particularities of the German-U.S.-American relations,
- dd) academic, job-related and personal ambitions relevant to the programme.

<sup>6</sup>After the interview, the members of the selection committee assess the student's performance in terms of the degree of qualification with respect to the double degree programme; the assessment is based on a scale as specified in sentence 1 letters bb).

#### (6) Students, who

- a) cannot be accepted to the double degree programme, or
- b) are no longer able to successfully complete the required examinations within the scope of the double degree programme without the examination entitlement in the Bachelor's degree programme "Weltliteratur/World Literature" having already expired, may only complete the Bachelor's degree programme in accordance with the provisions of appendix I no. I.
- (7) <sup>1</sup>Within the double degree programme, students will stay at the University of Göttingen during subject semesters 1 to 4; for subject semesters 5 and 6 they will stay at the UA. <sup>2</sup>The exact structure of the study programme and the list of offered modules are specified in appendix I no. II.
- (8) <sup>1</sup>Within the double degree programme, students from the UA will stay at the University of Göttingen during subject semesters 5 and 6. <sup>2</sup>Subject semester 1 through 4 as well as semester 7 and 8 are carried out at the UA. <sup>3</sup>The exact structure of the study programme and the list of modules offered at the University of Göttingen is specified in appendix I no. II. <sup>4</sup>Students from the UA may pass their module examinations at the University of Göttingen in either German or English.

- (9) <sup>1</sup>Repeat examinations of failed module examinations may also be taken at the partner university. <sup>2</sup>The examination conditions of the university offering the module apply; the assessment is also carried out by examiners of the university offering the module.
- (10) -rescinded-
- (11) <sup>1</sup>Within the double degree programme, supervisors of the Bachelor thesis are typically an eligible examiner from the University of Göttingen and the UA respectively. <sup>2</sup>Upon request it is possible that both authorized examiners come from the University of Göttingen, however, they should be of two different institutions involved in the degree programme, if possible. <sup>3</sup>The Bachelor thesis is generally to be written in English; upon request, the Bachelor thesis may be written in German, provided that an evaluation of German-language performance can be guaranteed. <sup>4</sup>In the case that one of the authorized examiners comes from UA, this person is to be appointed as an authorized examiner for the supervision or examination of Bachelor theses by the Examination Office of the Faculty of Humanities.
- (12) <sup>1</sup>After successful completion of the bachelor examination, the University of Göttingen and the UA each bestow the academic degree Bachelor of Arts (B.A.). <sup>2</sup>The two degrees may be carried separately, each in its own right. <sup>3</sup>If the two degrees shall be combined, they must be connected by means of a slash. <sup>4</sup>This equally applies to the abbreviated form.
- (13) The bachelor certificate from the University of Göttingen is issued in German and English and contains the supplement that the Bachelor's degree has been earned as part of the double degree programme, and moreoever that the certificate is only valid in connection with the certificate from the UA.

#### § 14 a Double Degree Programme with the East China Normal University (ECNU)

- (1) <sup>1</sup>The University of Göttingen and the East China Normal University, Shanghai, PR. China (hereinafter ECNU) jointly conduct a double degree programme, which can be completed as part of this of this degree programme. <sup>2</sup>The provisions of these examination and study regulations apply, unless otherwise stipulated below. <sup>3</sup>The courses offered by the ECNU are governed exclusively by the regulations of the ECNU.
- (2) <sup>1</sup>Students of the Bachelor's degree programme "Weltliteratur/World Literature" are eligible to participate in this programme in accordance with the following provisions. <sup>2</sup>The double degree programme can only be taken up in the winter semester. <sup>3</sup>Another prerequisite is that ECNU admits the student to the programme in accordance with its regulations.
- (3) <sup>1</sup>Access is granted to those who, at the time of registration, have successfully completed at least 24 C from modules of the degree programme and can demonstrate knowledge of the English language at least on the level C1 according to Common European Framework of Reference for

Languages (CEFR). <sup>2</sup>Before the start of mobility in the third year Chinese at the level of HSK 2 must be demonstrated; if applicable, modules of the required extent must be successfully completed in the second year to achieve this language level; otherwise, participation in the double degree programme is excluded.

- (4) Due to the regulations of the ECNU, at the end of the study period abroad at ECNU, usually at the end of the 6th semester, knowledge of the Chinese language at the HSK4 level must be demonstrated.
- (5) <sup>1</sup>The application for admission to the double-degree programme must be submitted at the latest 17 months before the start of the study abroad, i.e. by May 1, at the Seminar for Slavic Philology. <sup>2</sup>The application must be accompanied by the following documents:
  - a certificate of the examination achievements to date, including the credit points
  - proof of knowledge of the English language according to section 3 as well as
  - a curriculum vitae in tabular form, written in German or English, with a meaningful description
    of the educational background to date, which shows which practical knowledge and further
    professional qualifications the student has or which study-relevant stays abroad he or she
    has already completed.
- (6) For students as defined in section 2, 6 study places are available each year; in the event that more students eligible for admission apply for admission than number of places are available, a selection procedure shall be carried out in accordance with the following provisions.
- a) <sup>1</sup>The Faculty of Humanities of the University of Göttingen shall form a selection committee for the preparation of the selection decision. <sup>2</sup>This selection committee shall consist of three members, who belong to the full-time academic staff or to the group of university teaching staff, as well as one member of the student group in an advisory vote. <sup>3</sup>At least one member must belong to the professorial group. <sup>4</sup>The members shall be appointed by the Faculty Council of the Faculty of Humanities. <sup>5</sup>The term of office of the members is two years, that of the student member one year. <sup>6</sup>Reappointment is possible. <sup>7</sup>The selection committee has a quorum if at least two voting members are present. <sup>8</sup>The tasks of the selection committee are:
  - aa) surveying of the incoming applications for admission for formal correctness,
  - bb) conducting the selection interviews according to section 6,
  - cc) making decisions on the admission or rejection of the applicants.
- b) <sup>1</sup>Selection is made on the basis of ranking starting with the student with the most points (max. 26 points) which are awarded on the basis of the following criteria
  - aa) According to the result of the grade point average of the examinations rendered at the time of application:

<sup>2</sup>In case of identical ranking, the grade point average of the examination achievements at the time of application will be decisive. <sup>3</sup>The selection interview is usually held at the University in May by the selection committee; the University invites the students to the selection interview in good time; in justified exceptional cases, a video conference or a telephone video conference or a telephone selection interview are also permitted, provided that the identity of the student can be established beyond doubt; the details of the procedure in such cases shall be determined by the selection committee. <sup>4</sup>A record shall be made of the essential questions and answers of the interview shall be signed by the members of the selection committee; the minutes shall show the date and place of the interview, the names of the members of the selection committee, the name of the student and the assessment. <sup>5</sup>The selection interview covers the following suitability parameters:

- aa) Linguistic and cultural competence, interaction with the selection committee,
- bb) Intercultural competence,
- cc) Sensitisation with regard to the special features of German-Chinese relations,
- dd) Academic, professional and personal projects related to the programme.

<sup>6</sup>After the interview, the members of the selection committee shall evaluate the student according to the degree of suitability for the Double Degree Programme on a scale according to sentence 1 letters bb).

- (7) Students who
- a) cannot be considered in the double degree programme, or

- b) are no longer able to successfully complete the required achievements within the scope of the double degree programme without their examination entitlement in the Bachelor's degree programme "Weltliteratur/World Literature" having already expired, may only complete the Bachelor's degree programme in accordance with the provisions of appendix I no. I.
- (8) <sup>1</sup>In the framework of the double degree programme, the students of the University of Göttingen spend the 1st to 4th semester at the University of Göttingen and the 5th and 6th semester at ECNU. <sup>2</sup>Modules of the 3rd and 4th semester with a total of 22 C are offered jointly by the University of Göttingen and the ECNU. <sup>3</sup>Courses at the University of Göttingen are combined with e-learning offers at the ECNU and the examinations are carried out according to the examination regulations of the ECNU. <sup>4</sup>Further information can be found in the module descriptions. <sup>5</sup>The exact structure of the study programme and the modules that can be selected are specified in appendix I. no. III.
- (9) ¹In the framework of the double degree programme, the students of the ECNU spend the 6th and 7th semester at the University of Göttingen. ²The 1st to 5th and 8th semesters are spent at the at ECNU. ³The exact structure of the programme and the modules that can be selected at the University of Göttingen are specified in appendix I. no. III. ⁴For students of the ECNU module examinations at the University of Göttingen are conducted in German or English.
- (10) <sup>1</sup>Repeat examinations for failed module examinations can also be taken at the partner university. <sup>2</sup>The examination conditions of the university offering the module apply; the assessment is also carried out by examiners of the university offering the module.
- (11) <sup>1</sup>In the context of the Double Degree Programme, the supervisors of the Bachelor thesis are usually one authorised examiner from the University of Göttingen and one authorised examiner from the ECNU. <sup>2</sup>The Bachelor thesis is generally to be written in English; upon request, the Bachelor thesis can be written in German or Chinese, provided that the ECNU can guarantee an assessment of German-language performance or the University of Göttingen can guarantee an assessment of Chinese-language performance. <sup>3</sup>The appointment of Göttingen examiners to supervise or examine Bachelor's theses at the ECNU shall be made by the Examinations Office of the Faculty of Humanities after notification by the ECNU.
- (12) In deviation from § 9, section 4, sentences 1 and 2, the Bachelor thesis must be submitted to the Examination office responsible for the Bachelor thesis in accordance with appendix I, point III, exclusively in text form in the format of a commonly used word processing programme or in PDF format (unprotected) when taking the Double Degree Programme with the East China Normal University (ECNU).
- (13) <sup>1</sup>Upon successful completion of the Bachelor's examination, the University of Göttingen and the ECNU shall each award the degree Bachelor of Arts (B.A.). <sup>2</sup>The two degrees may each be used

separately. <sup>3</sup>If both degrees are to be used together, they shall be connected by a slash. <sup>4</sup>This also applies to the abbreviated form.

(14) The Bachelor's degree certificate of the University of Göttingen is issued in German and in English and contains the addition that the Bachelor's degree was acquired within the framework of a double degree programme and that the certificate is only valid in conjunction with the certificate of the ECNU.

#### § 14 b Double Degree Programme with the Voronezh State University (VSU)

- (1) <sup>1</sup>The University of Göttingen and the Voronezh State University, Voronezh, Russia, (hereinafter referred to as VSU) jointly conduct a double degree programme that can be completed as part of this degree programme. <sup>2</sup>The provisions of these examination and study regulations apply, unless otherwise stipulated below. The provisions of the VSU apply exclusively to the courses offered by the VSU.
- (2) <sup>1</sup>Students of the Bachelor's degree programme "Weltliteratur/World Literature" are eligible to participate in this programme according to the following regulations. <sup>2</sup>The double degree programme can only be taken up in a winter semester. <sup>3</sup>Another prerequisite is that VSU admits the student to the programme in accordance with its regulations.
- (3) <sup>1</sup>Access is granted to those who have successfully completed at least 50 C from modules of the degree programme and can prove knowledge of the Russian language at least on the level B2 according to the CEFR. <sup>2</sup>If knowledge of the Russian language has not yet been proven at level B2 of the Common European Framework of Reference for Languages (CEFR), modules to the required extent must be successfully completed before the start of mobility in the third year of study, on the basis of which this language level is achieved; otherwise participation in the double degree programme is excluded.
- (4) <sup>1</sup>The application for admission to the double degree programme must be submitted to the Department of Slavic Philology by October 10; it can be submitted at the end of the second semester at the earliest. <sup>2</sup>The application must be accompanied by the following documents:
- a certificate of the examinations taken so far, including credits
- a proof of knowledge of the Russian language according to section 3 as well as
- a curriculum vitae in tabular form, written in German or English, with an informative description of the student's educational background to date, stating what practical professional knowledge and other professional qualifications the student has or what study-related stays abroad he or she has already completed.

- (5) For students as defined in section 2, 6 study places shall be available each year; in the event that more students eligible for admission apply for participation than study places are available, a selection procedure shall be carried out in accordance with the following provisions.
- a) <sup>1</sup>For the preparation of the selection decision, the Faculty of Humanities of the University of Göttingen forms a selection committee. <sup>2</sup>This selection committee consists of three members who belong to the full-time scientific staff or the university teaching group, as well as one member of the student group with an advisory vote. <sup>3</sup>At least one member must belong to the professorial group. <sup>4</sup>The members shall be appointed by the Faculty Council of the Faculty of Humanities. <sup>5</sup>The term of office of the members is two years, that of the student member one year. <sup>6</sup>Reappointment is possible. <sup>7</sup>The selection committee has a quorum if at least two voting members are present. <sup>8</sup>The tasks of the selection committee are:
  - aa) surveying of the incoming applications for admission for formal correctness,
  - bb) conducting the selection interviews according to section 6,
  - cc) making decisions on the admission or rejection of the applicants.
- b) <sup>1</sup>The selection is carried through on the basis of a ranking list beginning with the student who has reached the highest score (max. 26 points), which is attributed based on the following criteria:
  - aa) based on the current average grade of the achievements completed at the time of application:

<sup>2</sup>In the event of equal ranking, the average grade of the achievements achieved at the time of application is decisive. <sup>3</sup>The selection interview normally takes place face-to-face with the selection committee at the university in October; the students are formally invited to attend the selection interview by the university in a timely manner; in special cases, video conferencing or interviews on the phone are acceptable, so long as the identity of the student can be established unequivocally; in such cases, the details of the procedure are laid down by the selection committee. <sup>4</sup>The essential questions and answers of the interview must be put on record, which at the end must be signed the members of the selection committee; the record must document time and place of the interview, the names of the committee members, the name of the student, and the assessment. <sup>5</sup>The selection interview includes the following parameters of qualification:

- aa) language skills and cultural competence; interaction with the selection committee,
- bb) intercultural competence,
- cc) awareness of the particularities of the German-U.S.-American relations,
- dd) academic, job-related and personal ambitions relevant to the programme.

<sup>6</sup>After the interview, the members of the selection committee assess the student's performance in terms of the degree of qualification with respect to the double degree programme; the assessment is based on a scale as specified in sentence 1 letters bb).

#### (6) Students who

- a) cannot be considered in the double degree programme, or
- b) are no longer able to successfully complete the required achievements within the scope of the double degree programme without their examination entitlement in the Bachelor's degree programme "Weltliteratur/World Literature" having already expired, may only complete the Bachelor's degree programme in accordance with the provisions of appendix I no. I.
- (7) <sup>1</sup>In the double degree programme, students of the University of Göttingen spend the 1st to 4th semester at the University of Göttingen, and the 5th and 6th semester at VSU. <sup>2</sup>The exact structure of the programme and the modules that can be selected are specified in appendix I, no. IV.
- (8) <sup>1</sup>As part of the double degree programme, students at VSU spend the 5th and 6th semester at the University of Göttingen. <sup>2</sup>The 1st to 4th semester as well as the 7th and 8th semester are spent at VSU. <sup>3</sup>The exact structure of the study programme and the modules that can be selected at the University of Göttingen are specified in appendix I, no. IV. <sup>4</sup>For students at VSU, module examinations at the University of Göttingen are conducted in German or English.
- (9) <sup>1</sup>Repeat examinations of failed module examinations may also be taken at the partner university. <sup>2</sup>The examination conditions of the university offering the module apply; the assessment is also carried out by examiners of the university offering the module.

- (10) <sup>1</sup>In the context of the double degree programme, the supervisors of the Bachelor thesis are usually an authorized examiner of the University of Göttingen and an authorized examiner of VSU. <sup>2</sup>The Bachelor thesis is generally to be written in English; upon request, the Bachelor thesis can be written in German, provided that the VSU can guarantee the evaluation of the German-language performance; it is also possible to write the Bachelor thesis in Russian upon request, provided that the University of Göttingen can guarantee the evaluation of the Russian-language performance. <sup>3</sup>The appointment of Göttingen examiners to supervise or examine Bachelor theses at VSU is made by the Examination Office of the Faculty of Humanities after notification by VSU.
- (11) In deviation from § 9 section 4 sentences 1 and 2, the Bachelor thesis must be submitted to the Examination Office responsible for the Bachelor thesis in accordance with appendix I, no. IV in text form only in the format of a generally used word processing programme or in PDF format (unprotected) when taking the double degree programme with VSU.
- (12) <sup>1</sup>Upon successful completion of the Bachelor's examination, the University of Göttingen and VSU shall each award the degree of Bachelor of Arts (B.A.). <sup>2</sup>The two degrees may be used separately. <sup>3</sup>If both degrees are to be used together, they are to be connected by a slash. <sup>4</sup>This also applies to the abbreviated form.
- (13) The Bachelor's degree certificate of the University of Göttingen is issued in German and in English and contains the addition that the Bachelor's degree was acquired within the framework of a double degree programme and that the certificate is only valid in conjunction with the certificate of VSU.

#### § 15 Entry into Force; Transitional Provisions

- (1) These regulations enter into force following its publication in the Official Bulletin I of Georg-August-Universität Göttingen as per 01.10.2018.
- (2) ¹Students who entered their studies prior to the entry into force of an amendment of these regulations and who have been continuously enrolled since, will be examined according to the examination and study regulations in the version prior to the entry into force of the amendment. ²In the case of pending examinations, this does not apply to module overviews and descriptions, unless the legal entitlements of a student calls for a different decision by the examination board. ³A different decision can be reached especially in cases where an examination can be repeated or a compulsory or elective compulsory module has changed significantly or been cancelled. ⁴The examination board can draw up general rules for this purpose. ⁵Examinations according to these regulations in the version prior to the entry into force of the amendment will be conducted for the last time in the fourth semester after entry into force of the amendment. ⁶Students identified in sentence 1 may submit an application if they wish to be examined according to the amended regulations.

- (3) ¹Deviating from section 2, students who began their studies prior to 30.09.2019 will be examined according to the current Examination and Study Regulations in the version published on 01.10.2019; students may submit an application until 31.03.2020 if they wish to be examined according to the regulations in the version valid until 30.09.2019. ²Nevertheless, if the current Examination and Study Regulations in the version from 01.10.2019 are applicable, this does not touch upon the course of studies completed prior to 30.09.2019, especially successfully completed module examinations. ³If the current Examination and Study Regulations in the version valid until 30.09.2019 are applicable, this applies specifically to pending examinations, however not to the module directory or module descriptions, unless the protection of trust toward the student suggests a deviating decision granted by the examination board. ⁴A deviating decision is possible especially in such cases where an examination component may be repeated or where a compulsory or elective compulsory module has been changed considerably or been cancelled. ⁵The examination board may formulate general regulations in this context. ⁶Examinations according to these Examination and Study Regulations in the version valid until 30.09.2019 will be conducted for the last time during the summer semester of 2022.
- (4) ¹Departing from section 2, students who began their studies before 30.09.2020 shall be examined in accordance with these Examination and Study Regulations in the version valid from 01.10.2020; on application, to be submitted by 31.03.2021 at the latest, they shall be examined in accordance with the provisions of these Examination and Study Regulations in the version valid up to 30.09.2020. ¹Insofar as these Examination and Study Regulations are to be applied in the version valid from 01.10.2020, courses of study completed by 30.09.2020, in particular module examinations passed or failed, shall remain unaffected. ³Insofar as these Examination and Study Regulations apply in the version valid until 30.09.2020, this shall not apply to module overviews and descriptions in the case of examinations still to be taken, unless the protection of a student's legitimate expectations requires a deviating decision by the examination board. ⁴A deviating decision is possible in particular in cases in which an examination performance can be repeated or a compulsory or compulsory elective module has been substantially changed or cancelled. ⁵The examination board may make general regulations in this regard. ⁶Examinations according to these examination and study regulations in the version valid until 30.09.2020 shall be taken for the last time in the summer semester 2023.
- (5) <sup>1</sup>Departing from section 2, students who began their studies before 30.09.2021 shall be examined in accordance with these Examination and Study Regulations in the version valid from 01.10.2021; on application, which must be made by 31.03.2022 at the latest, they shall be examined in accordance with the provisions of these Examination and Study Regulations in the version valid up to 30.09.2021. <sup>2</sup>Insofar as these Examination and Study Regulations are to be applied in the version valid from 01.10.2021, study progressions carried out up to 30.09.2021, in particular module

examinations passed or failed, shall remain unaffected. <sup>3</sup>Insofar as these Examination and Study Regulations are to be applied in the version valid until 30.09.2021, this shall not apply to module overviews and descriptions in the case of examinations still to be taken, unless the protection of the confidence of a student requires a deviating decision by the Examination Committee. <sup>4</sup>A deviating decision is possible in particular in cases in which an examination performance can be repeated or a compulsory or required elective module has been substantially changed or cancelled. <sup>5</sup>The Examination Commission may make general regulations in this regard. <sup>6</sup>Examinations in accordance with these Examination and Study Regulations in the version valid until 30.09.2021 will be taken for the last time in the summer semester 2024.
